Gov. Edwards Falsely Used AG's Name to Try To Intervene in Criminal Case Against Pastor

In Scathing Rebuke, Atty. Gen. Says Gov. Had No Authority to File in Supreme Court

NEW ORLEANS — In what have to be two of the most extraordinary filings in the history of the Louisiana Supreme Court, Gov. John Bel Edwards tried to intervene in a criminal case pending before the court — an unprecedented move — and Attorney General Jeff Landry filed a motion to throw out the governor's intervention because he says the governor falsely filed the document in the name of the Attorney General. The AG also said the

governor has no authority to intervene in a criminal case on his own.

It all began Tuesday, Jan. 18, when Gov. Edwards filed a 76-page document with the Supreme Court claiming to have the right to intervene in the criminal case charging Rev. Tony Spell of Central with the crime of holding church contrary to Edwards' orders back in March 2020. The document purported to be from the Attorney General.

Edwards wrote the "law" which supposedly made it a crime for Pastor Spell to hold church. Actually, he issued an Emergency Order, which the governor says trumps the First Amendment to the U.S. Constitution.

The Attorney General says the governor has no power to make laws and his orders cannot supercede the Constitution.

Edwards' attempted intervention filed with the Supreme Court

Tuesday would allow the governor to assist in prosecuting the pastor.

Rev. Spell's attorney, Jeff Wittenbrink said Edwards is trying to serve simultaneously in all three branches of government. As governor, he is head of the executive branch. As a lawmaker, he is part of the legislative branch. And as a prosecutor, he is part of the judicial branch. Wittenbrink said that is called one-man rule and doesn't fly in American-style government.

On Wednesday, Jan. 19, Attorney General Jeff Landry filed a "Motion to Strike or Alternatively, Opposition to Motion to Intervene Filed by Gov. John Bel Edwards."

The Attorney General's motion is extraordinary in its frankness:

to strike the Motion to Intervene filed by Governor John Bel Edwards, through Special Assistant Attorneys General, filed on January 18, 2022, or, in the alternative, opposes the motion to intervene filed by the Governor for the reasons set forth below.”

“The Motion to Intervene – submitted, in part, by the attorneys with the law firm of Sher Garner Cahill Richter Klein & Hilbert, LLC and by Jack M. Weiss, Attorney at Law – was filed by those counsel purportedly as ‘Special Assistant Attorneys General.’ However, Attorney General Jeff Landry has never appointed these attorneys to represent the Governor in connection with any criminal proceeding against Applicant, Mark Anthony Spell, including the instant writ application. It would not be proper for the Attorney General to make an appointment for special counsel, as this is not either a risk-covered case or a criminal case being prosecuted by the Attorney General.”

“Additionally, and very deceptively, the attorneys filing the Governor’s Motion to Intervene included ‘Jeff Landry Attorney General’ in the list of ‘Attorneys for Gov. John Bel Edwards,’ and on their signature block. Let us be clear. Jeff Landry does not represent Gov. Edwards in this matter nor does any attorney with the Louisiana Dept. of Justice. This filing was done without the knowledge or consent of the Attorney General or anyone with authority to give such consent.”

“Furthermore, neither the Attorney General nor any Assistant Attorney General appointed by the Attorney General were consulted or notified about such representation in this matter. A search of Department of Justice records revealed no approval of the appointment of Jack Weiss, James Garner, Darnell Bludworth, Joshua Force and Christopher Chocheles as attorneys for or on behalf of the Gov. John Bel Edwards in this matter.”

“Governor’s counsel are well aware that they are not authorized to represent that they are Special Assistant Attorneys General to this Honorable Court without an appointment by the Attorney General. Previously, counsel were instructed to correct future pleadings in a case where they were representing the Governor, in order to avoid confusion to this Honorable Court. See Exhibit A. The continued use of the Special Assistant Attorneys General title to this Court—the Supreme Court of Louisiana—is misleading and improper, and it appears intentional.”

“Unlike the Governor, the Attorney General has constitutional authority (1) to institute, prosecute, or intervene in any civil action or proceeding; and (2) upon the written request of a district attorney, to advise and assist in the prosecution of any criminal case. La. Const. art. IV, § 8.”

“The Governor does not. Additionally, it is the Attorney General alone who, as a matter of right, shall be heard on constitutional challenges. La. Code Civ. P. art. 1880.”

Governor to “effect[] [the LHSEADA’s] provision by executive order, proclamation, or regulation.”²⁶

In sum, in federal and state proceedings against the Governor, Spell launched the exact same legal assault on the Governor’s Emergency Proclamations: they purportedly violated the federal and state constitutions and exceeded the Governor’s authority. Thus Spell himself has dramatically affirmed the Governor’s central role and direct interest in promulgating and defending the Proclamations. Once again, Spell now challenges the Governor’s ability to fulfill the duties imposed by the LHSEADA (and the LHEPA) to protect the lives of Louisiana residents.²⁷ Because no one but the Governor owes this duty, or has a greater or even comparable interest in defending the lawfulness of his Emergency Proclamations, the Governor prays that he be granted leave to intervene in this Writ Proceeding.

INTERVENTION BY GOVERNOR IN CASE OF PASTOR SPELL PURPORTEDLY SIGNED BY ATTORNEY GENERAL — On Tuesday, Jan. 18, 2022, Gov. John Bel Edwards filed with the Louisiana Supreme Court a motion to intervene in the criminal case against Rev. Tony Spell of Central. The documents filed by Edwards purported to show that they were authorized by Louisiana Attorney General Jeff Landry. However, the attorney general filed documents with the Supreme Court on Wednesday, Jan. 19, 2022, that neither he nor his office authorized the filing of these documents.

“Very deceptively, the attorneys filing the Governor’s Motion to Intervene included ‘Jeff Landry Attorney General’ in the list of ‘Attorneys for Gov. John Bel Edwards,’ and on their signature block. Let us be clear. Jeff Landry does not represent Gov. Edwards in this matter nor does any attorney with the Louisiana Dept. of Justice. This filing was done without the knowledge or consent of the Attorney General or anyone with authority to give such consent.”

“Unlike the Governor, the Attorney General has constitutional authority (1) to institute, prosecute, or intervene in any civil action or proceeding; and (2) upon the written request of a district attorney, to advise and assist in the prosecution of any criminal case. case, where the State of Louisiana is represented by the local District Attorney. The use of ‘Special Assistant Attorneys General’ and the name and title of the Attorney General affixed to the Governor’s pleadings, and appearing on the signature block as an attorney in the case, denotes that the Attorney General somehow authorized this filing in a criminal case. Such representation is patently false.”

“The Governor’s counsel appears to blur the line of the Attorney General’s role as criminal prosecutor (although not a prosecutor in this case) and the Attorney

General’s role as counsel for the State in civil litigation. This filing implies that the Attorney General is trying to influence or advocate for a decision in a criminal matter. It is improper, misleading, and unprofessional.”

“These lawyers have made representations to this court that are clearly false and inaccurate. Jack Weiss, James Garner, Darnell Bludworth, Joshua Force and Christopher Chocheles do not have the authority to act on behalf of the Attorney General or the State of Louisiana in this matter, and they have never been appointed as Spe-

cial Assistant Attorneys General in this matter.”

“WHEREFORE, Attorney General Jeff Landry prays that the motion to strike be granted and for all other relief this Honorable Court deems appropriate. Additionally, the Attorney General prays that any costs associated with this matter and the motion to intervene be taxed against the attorneys for the Governor.”

Central Community School Board Opposes New 185-Lot Development on Hooper Road

Board Members Raise Concerns About Flooding

CENTRAL — The Central Community School Board last week voted unanimously to oppose a 185-lot development proposed for Hooper Road. The proposed subdivision would be located west of the Comite River outside the City of Central but inside the Central Community School District.

It would feature 50x120 lots. Because it is located outside the City of Central, the proposal will be heard by the East Baton Rouge Parish Planning & Zoning Commission instead of the City of Central Planning Commission. A hearing is planned for March.

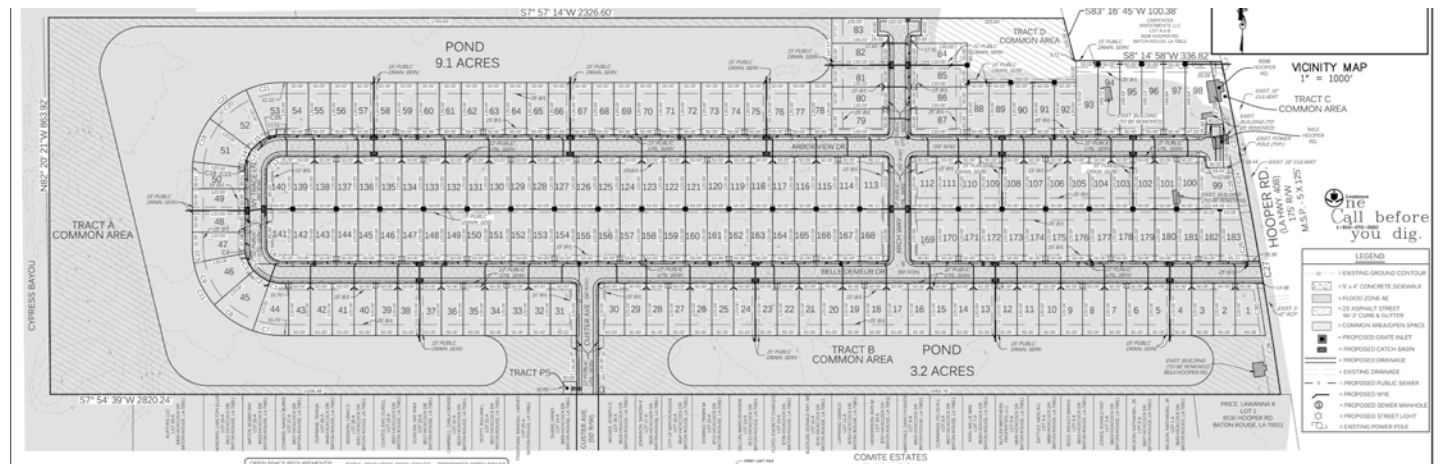
Board opposition to the proposal began last week when Central School Board member Kim Powers came out against the development. She said the area is flood prone, and the development could make flooding worse.

She also said the development would bring 300-400 additional students to the school system without sufficient revenue to pay the costs,

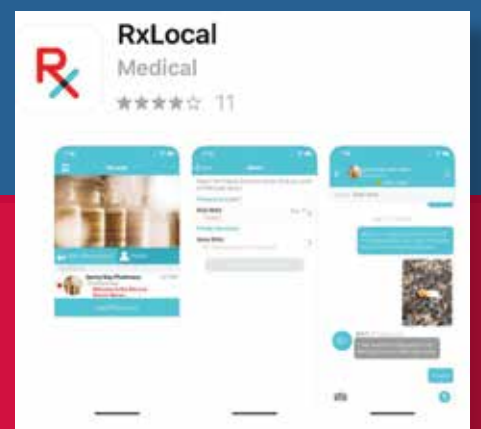

CENTRAL — Ronnie Devall, 74, a life-long resident of Central, Louisiana, passed away on December 30, 2021 after a brave battle with Parkinson's disease.

He was born on September 4, 1947. He graduated from Southeastern Louisiana University and Louisiana State University. He married his high school sweetheart, Carolyn, on August 18, 1967. He loved sports, traveling, playing golf, and spending time with his grandchildren.

He devoted his life to teaching and coaching at Park Forest Middle School, Central High School, and Broadmoor High School.

He led Broadmoor to win two basketball state championships and was named Louisiana High School Coach of the Year in both 1985 and 1987. He was inducted into the Broadmoor High School Hall of Fame. He was an assistant basketball coach at Southeastern

In 2012, he was inducted into the Central High School Hall of Fame as someone who made a "significant impact" on Central High School. He knew how to build a team, whether on the court or in the classroom, and his passion and leadership made everyone around him better.

He is survived by his wife of 54 years, Carolyn Devall; daughter Rodlyn McAdams; son Eric Devall and his wife Malana; Calvin Babin; grandchildren Madison Mc-

because of the lack of commercial and retail properties in the area.

During debate, board member Sharon Browning said the development would adversely affect the school system by producing an overwhelming number of students.

Ms. Browning also discussed the flooding issue. She said, "If you are familiar with the area, you know that the slightest rain forces residents of nearby Comite Estates to move their cars onto Hooper Road. You can imagine what a 12-foot moat [detention pond] around the development would cause!"

Board member Dr. David Walker said the proposed rezoning would reduce lot sizes from "decent" to "extremely small."

Board member Roxanne Atkin-

son said, "I'm glad we're taking a stand, and I appreciate the wording of the resolution."

Board member Dr. Keith Holmes said the board and members of the public need to show up at the EBR Planning Commission to make their voices heard at the hearing in March.

board included language by board member Kim Powers that asked the EBR Planning Commission to adopt a policy that would notify the Central School Board when it receives applications for new developments in the area outside the City of Central but inside the Central school district.

Then the school board would

have 15 days to express their recommendations on the proposal.

During the public hearing on the resolution, a resident asked why any part of the Central school district would be outside the City of Central. Dr. Holmes said that at the time the Central school system was being created, residents of nearby areas with large minority populations were given the opportunity to be included in the school district, and the area west of the Comite River desired to be included.

Supreme Court Strikes One Mandate, Upholds Another

What Does SCOTUS Vaccine Ruling Mean?

If You Do Not Want Federal Control, Don't Accept Federal Money

WASHINGTON — Last week the United States Supreme Court announced its 6-3 decision striking down a rule issued by OSHA requiring private employers with 100 or more employees to force their employees to be vaccinated for COVID.

At the same time, the court announced its 5-4 decision upholding the U.S. Department of Health and Human Services rule requiring health care facilities receiving Medicare or Medicaid funds to

force their employees to be vaccinated. Here are some important results of the rulings:

1. The rulings were not directly about constitutional rights but about the Supreme Court interpreting the statutory authority granted by Congress to two separate agencies — OSHA and the U.S. Department of Health. The court found that the authority was granted to the Department of Health but not to OSHA.

2. The OSHA rules affecting large employers are dead, and the 100 million or more private employees who would have been mandated to take the vaccine will not be required to do so.

3. Large private employees could still require their employees to take the vaccine in “at-will employment” states. However,

if a private employer attempted to enforce such a rule on their own, the employees could still seek a medical exemption or a religious exemption.

4. Under the second ruling, hospitals and other health care facilities, which contract with the U.S. Dept. of Health for Medicare and Medicaid services, are required to enforce the vaccine mandate. This is due to the language in the statutory grant of authority to the Dept. of Health and the fact that these facilities are accepting government funds. However, employees could still seek a medical or religious exemption.

5. Earlier this week, the Louisiana Supreme Court ruled in a separate case that wholly private employers in Louisiana (not acting on behalf of the state) could require

employees to be vaccinated, since this is an “at-will employment” state. This means employers can fire employees for any reason (except racial, sexual or religious discrimination). However, such employees could still seek a medical or religious exemption.

6. In Louisiana, Article I, Section 5 (Right to Privacy) of the Louisiana Constitution appears to protect employees of the state, local government, and private employers acting on behalf of government from being required to take a vaccine against their will.

7. Even employers under the Dept. of Health mandate still have a lot of leeway to protect their employees from the mandatory vaccine if they desire to do so. They can do so within the context of the “plan” they adopt.

Louisiana Supreme Court Also Weighs in on Vaccine Mandates

NEW ORLEANS — Last week’s ruling by the Louisiana Supreme Court says that Louisiana health care providers can impose a vaccine mandate on their employees — seemingly ending the controversy over vaccine mandates for health care workers in Louisiana.

But that is far from the truth! The case was very unusual in that the plaintiffs — the physicians and

nurses suing Ochsner’s and others — stipulated something that simply wasn’t true. They stipulated that the hospitals they were suing are strictly private parties, not state actors. The court ruled that since the hospitals were stipulated as private parties, the Right to Privacy provisions of the Louisiana Constitution provide the doctors and nurses no protection.

The intent of Article 1, Section 5 (Right to Privacy) of the state constitution is to prohibit the state from violating citizens’ Right to Privacy. However, in reality, these large hospitals are in fact state actors. For example, Ochsner’s receives over \$100 million a year from the state and in mandating vaccines, it was acting on behalf of the Biden Administration.

As Jimmy Faircloth, the attorney for the plaintiffs, said, another group of physicians and nurses can go into court next week and file suit against the very same hospitals and have an excellent chance of winning. But they will need to allege that Ochsner’s and the oth-

ers have been acting on behalf of the government and therefore that the State of Louisiana is violating the Right to Privacy of the plaintiffs.

If that case is made, the court will

need to review these vaccine mandates in an entirely different light. Just bear in mind that this decision only relates to wholly private employers, not the state or employers acting on behalf of the state.

“This serious misconduct will garner the attention of our judicial branch and possibly be grounds for impeachment, maybe prison, but certainly a loss of respect and credibility from professional people who see his personal grudge against a Pentecostal pastor.”

If the Supreme Court agrees that the governor or his attorneys have engaged in serious misconduct, the court has a variety of tools at their disposal. However, the case is so unusual and the facts so strange that it is difficult to know what, if anything, the court may decide to do.

and thereby condoned what has been going on.

However, a few brave elected officials, business owners, attorneys, and ordinary citizens have refused to be silent or go along with clear violations of the Constitution.

The Central City News is honoring 25 of them. They have risked their careers and in some cases their freedom in order to stand firmly against the rise of tyranny and lawlessness in Louisiana.

argues the case before the highest courts in Louisiana and the nation. Her appearance before the United States Supreme Court on vaccine mandates gained applause across the country.

• **Rev. Tony Spell**, the pastor of Life Tabernacle Church in Baton Rouge, is the only person who has gone to prison in Louisiana for disobeying the mandates of Gov. John Bel Edwards. From the first day of Edwards' emergency order, Rev. Spell has been consistent in saying he would continue holding worship services at his church. The Governor, Mayor-President, Sheriff, District Attorney, commander of State Police, State Fire Marshal, Central police chief, and other officials have put tremendous pressure on pastor Spell with every imaginable threat. Ultimately, he was thrown into parish prison. However, he was soon released and continued holding church at "The Church That Never Closes." For the past 62 years, he and his grandfather have held more than 9,500 services without missing a single one. His criminal case is now pending before the Louisiana Supreme Court, and his civil case is before the U.S. Fifth Circuit Court of Appeals.

• **Danielle Bunch**, owner of Firehouse BBQ in Watson, refused to comply with the Govern-

or's mask mandate, despite being threatened with arrest and closure of her business by the State Dept. of Health. Attorney Jeff Wittenbrink has been defending her. Firehouse BBQ has never closed, is still open, and doing well. Her case is dormant in the District Court in Livingston Parish.

• **Donnie Calloway**, owner of Calloway's Health & Fitness at 13436 Jefferson Hwy in Baton Rouge, refused to close its doors when Gov. Edwards ordered a lockdown, since Edwards had no legal authority to do so. Calloway said if there is anything that should be open in these times, it is a gym. Despite threats from the state, Calloway's Gym has remained open

from March 2020 to the present.

• **Jimmy Faircloth**, attorney in Alexandria and former executive counsel for Gov. Bobby Jindal, has been representing physicians and nurses who have been threatened with being fired by their employers for refusing the vaccine. His brilliant arguments and legal briefs have helped the courts and the legal community understand the important constitutional issues at stake.

• **Jeff Wittenbrink**, attorney for Rev. Tony Spell at Life Tabernacle and for Danielle Bunch at Firehouse BBQ, has proven himself to be a outstanding constitutional lawyer that can do battle with the

best legal minds in the state. He has faced a complex legal situation and taken his clients from the district court to the supreme court at the state and federal levels. The case against Danielle Bunch is obviously going nowhere, and Rev. Spell appears likely to have major victories for the First Amendment in both state and federal courts.

• **Federal District Judge Terry Doughty** of Louisiana had the

courage to place separate injunctions against the Biden Administration's vaccine mandate for health care workers and its vaccine mandate for workers in Head Start programs. Doughty, who was appointed by President Trump in 2015, imposed his injunction over 24 states. <https://www.virginiamercury.com/2022/01/04/federal-judge-blocks-biden-vaccine-mandate-for-head-start-workers-in-24-states/>

• **Rep. Kathy Edmonston** (R-Gonzales) has been a leader in fighting mask mandates and vaccine mandates in the Louisiana Legislature. Among her many legislative accomplishments were passage in 2021 of HB349 to prohibit listing vaccine status on drivers license for use as vaccine passport {vetoed by governor}. HB498 to prohibit discrimination based on vaccine status (vetoed by governor). HR20 which requires schools and colleges to advise students and parents that vaccines are voluntary for Louisiana students under R.S.17:170. Rep. Edmonston has been a leading voice against mandates since March 2020.

• **Rep. Danny McCormick** (R-Oil City) has been an effective

legislator fighting for freedom in Louisiana. In 2021, he authored and passed HB103, which provided that any employer who mandates a vaccine would be liable for any harm which resulted to the employee (vetoed by governor). He also authored HCR5 which suspended all criminal penalties against pastors or anyone else for

conducting religious services in violation of the governor's emergency orders. That resolution has the effect of law and, as a suspension of the law, cannot be vetoed. Rep. McCormick organized some of the first rallies opposing the governor's lockdowns.

• **Rep. Valarie Hodges** (R- See ORDINARY on Page 10

Central) has been one of the most vocal critics of Gov. John Bel Edwards' mask mandates and vaccine mandates. She has been a leader in the legislature and at public rallies in support of religious liberty. Rep. Hodges was also instrumental in making sure Covid 19 was not used to open the floodgates to voter fraud in her election reform legislation and other election reform bills considered by the legislature.

- **Rep. Beryl Amedee** (R-Houma) has fought hard to end the mask and vaccine mandates. In 2020, she authored HB642 to prohibit employers from mandating their employees to accept a vaccine; HB61 restricting the power of the governor to declare an emergency; HB82 prohibiting a school from sharing a student's health information with the State Dept. of Health without parental permission; HB90 limiting orders quarantining persons, and HB99 allowing nursing home residents to have visitors. In 2021, she authored HB578 protecting the bodily autonomy of individuals to decide for themselves what medications or vaccines they will receive.

- **Rep. Larry Frieman** (R-Covington) has been a strong opponent of Gov. Edwards' mandates. In 2020, he authored HB15 to provide that either house of the legislature could terminate any part of a governor's emergency order, such as a mask order or a ban on worship services. In 2021, he authored HB149 to allow both houses to vote to terminate any part of a governor's emergency order. The latter bill passed both houses but was vetoed by the governor. Rep. Frieman has been a frequent speaker at rallies in opposition to the governor's mandates.

- **Jill Dillingham Hines**, president of Louisiana Health Freedom, has provided sound scientifically-based advice to elected officials, the media, and the public throughout the pandemic. Her honesty has resulted in Facebook and other left-wing social media outlets banning her and Louisiana Health Freedom for varying periods. She has an active presence at the legislature, working to defend the right of citizens to make their own health care decisions.

- **Jeff Crouere** of New Orleans is an experienced journalist who writes a weekly newspaper column, hosts a daily radio talk show, and does a weekly TV show on one of the major TV stations in the city. Throughout the pandemic, he has been a consistent voice fighting mask mandates and vaccine mandates and the other crazy decrees of the Mayor of New Orleans. Actually, he has been one of the few voices in New Orleans speaking out. He is often the keynote speaker at rallies at the state capitol and anywhere else in defense of liberty.

- **Dr. Rhett Bergeron**, M.D., of Baton Rouge and Atlanta has been one of the few physicians in Louisiana openly speaking against mask mandates and vaccine mandates. His two-page article in the April

2020 edition of the *Central City News* (pages 6-7) was one of the few uncensored sources in the nation where physicians and the public could understand how to protect themselves during the pandemic. His Covid-19 treatment protocol in the December 2021 edition of the *Central City News* provided the latest scientific and medical knowledge available. For him to speak out publicly came at great risk personally and professionally.

- **Dr. Jeff Andry** of Slidell has also been a strong voice emphasizing early treatment of Covid 19 including the use of hydroxychloroquine. He joined with Dr. Bergeron to publish an early treatment protocol in the December 2021 issue of the *Central City News*, which influenced physicians across the state.

- **Jonathan Koepfel** was a Spanish teacher at Fountainbleu High School in St. Tammany Parish when Gov. John Bel Edwards issued his mask mandate for students. Koepfel spoke out strongly at St. Tammany Parish School Board meetings that children are not vulnerable to Covid19 and that the masks don't work. He refused to take the mask, and he was fired from his job as a public school teacher. He has sued the St. Tammany Parish School Board for this violation of his rights. Last September, he started a construction company. He is working to elect new members of the St. Tammany school board. He is considering running for the Louisiana House in 2023.

- **Susie Labry** is a long-time citizen activist and motion picture actress. She closely monitors the Louisiana Legislature and grades the conservative voting record of each legislator with an emphasis on their votes on Gov. Edwards' mandates. Her ratings have provided valuable understanding of how legislators vote on the mandates, as opposed to how they present themselves to the public.

- **Michael Lunsford**, president of Citizens for a New Louisiana, a non-profit organization that focuses on government transparency, especially at the local level. Lunsford and his group work mostly behind the scenes to keep govern-

ment honest and protect our liberty. Lunsford and his Baton Rouge director Jamie Pope worked hard on the petition by the Louisiana House to terminate the governor's emergency orders. One of their challenges was to get the signature of House Speaker Clay Schexnayder, which he ultimately did. They have been staunch opponents of Edwards' mandates.

- **Moon Griffon**, long-time radio talk show host who many consider the Rush Limbaugh of Louisiana, has been a strong statewide voice throughout the pandemic pushing government to respect the Constitution and not Gov. Edwards' illegal mandates. He blasts away daily with breaking news, insightful commentary, and Cajun humor that is devastating to leftists and socialists everywhere but especially in Louisiana and the Governor's Mansion.

- **Kim Powers**, newly-elected member of the Central Community School Board, began fighting Gov. Edwards' mask mandate in the spring of 2020. When the State Board of Elementary & Secondary Education finally held a hearing on the matter in June 2020, she attended to speak on behalf of her two girls against the mandate. Instead, because she was not wearing a mask, six officers of the Department of Public Safety (not State Police) under the direction of the governor physically removed her from the meeting. Ms. Powers cited Art. 12, Section 3 of the Louisiana Constitution which gives every citizen the right to attend public meetings without wearing a mask, but they removed her anyway. She since filed suit against BESE, and that case has been to the 1st Circuit Court of Appeal and is now back in the court of District Judge Eboni Johnson-Rose. Ms. Power has become a popular speaker at rallies against the mandates. Then last year she ran for a vacancy on the Central Community School Board and was elected in a landslide. Since being elected, she has been having a positive impact on the board.

- **Alana Newman** is a mother and leader of Health Freedom Summit. Last summer, she was attending a meeting of the Louisiana

House Health & Welfare Committee at the State Capitol, waiting to testify against mask mandates in schools. The chairman, Rep. Larry Bagley, presided over the meeting for five hours without a mask. Yet, he demanded over and over that all of the 150 people in the room put on masks. Some refused. Then out of the blue, Rep. Bagley pointed to Ms. Newman who was sitting quietly in the room and ordered guards to physically remove her from the room. They picked her up, dropped her on the floor, showing her underwear, then picked her up again and dumped her in the hallway. Their brutality and rudeness — in a state where people have a constitutional right to attend public meetings — was shocking. Ms. Newman is considering filing suit. She is preparing for the Health Freedom Summit, which she sponsors.

- **Lydia Romero** is a mom who has been watching the Lafayette Parish Council and the Lafayette Parish School Board for several years. She does what good citizens are supposed to do: Exercise her right to attend public meetings and comment on what they are doing. In October 2021, she was attending a meeting of the Lafayette Parish School Board when two sheriff deputies accosted her and demanded she put on a mask. She told them she had a legal right to attend the meeting without a mask. They proceeded to lift her out of her seat and carry her out of the meeting, depriving her of her right to attend a public meeting in accordance with Art. 12, Section 3 of the Louisiana Constitution. In addition, rather than the deputies being charged with a crime, they filed criminal charges against Lydia Romero. She is set for pre-trial hearing on April 7. Ms. Romero is considering filing suit against the Sheriff's office and the school board.

- **Claston Bernard** was a two-time U.S. National Champion for LSU in the Decathlon. For several years, he was the best all-around athlete in the United States. He also ran for Jamaica in the Olympics. In recent years, Bernard has become a leading spokesman for the Constitution and the Bill of Rights. He speaks extensively across Louisiana opposing mask mandates, vaccine mandates, and other violations of our liberty.

These 25 heroes are among hundreds, perhaps thousands of Louisianians who have gotten out of their comfort zone to stand and speak out against Gov. John Bel Edwards and his lawless rule.

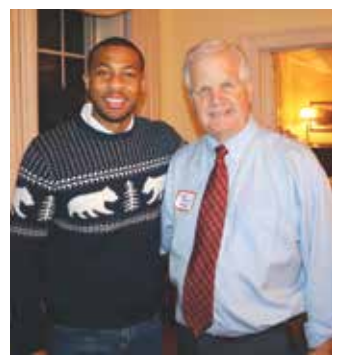

Central School Board Getting Close To Reapportionment of Districts

With Growth Being Fairly Uniform Across Central School District, School Board Lines To See Little Change

CENTRAL — Under state law, the Central Community School Board will have to review Census data and determine what changes may be necessary to apportion its seven seats in accordance with law.

Because growth in the school district has been fairly uniform across the district, few changes in district boundaries will be necessary, according to Central schools Supt. Jason Fountain.

The latest version of the reapportionment plan is shown at right.

Dr. Fountain said, “The School Board began working on the re-districting map in the fall. Our demographer pulled our current maps with census data and showed where we had to make adjustments.”

“The first Committee of the Whole met on November 3. At that meeting, the demographer brought two maps that would meet the requirements.”

“School Board members and others present talked through the options and looked at the maps extensively at that meeting. The demographer then took the feedback from the meeting and created the map that is shown.”

“The process is not complete. We will have another public meeting soon for input to be given on the suggested map.”

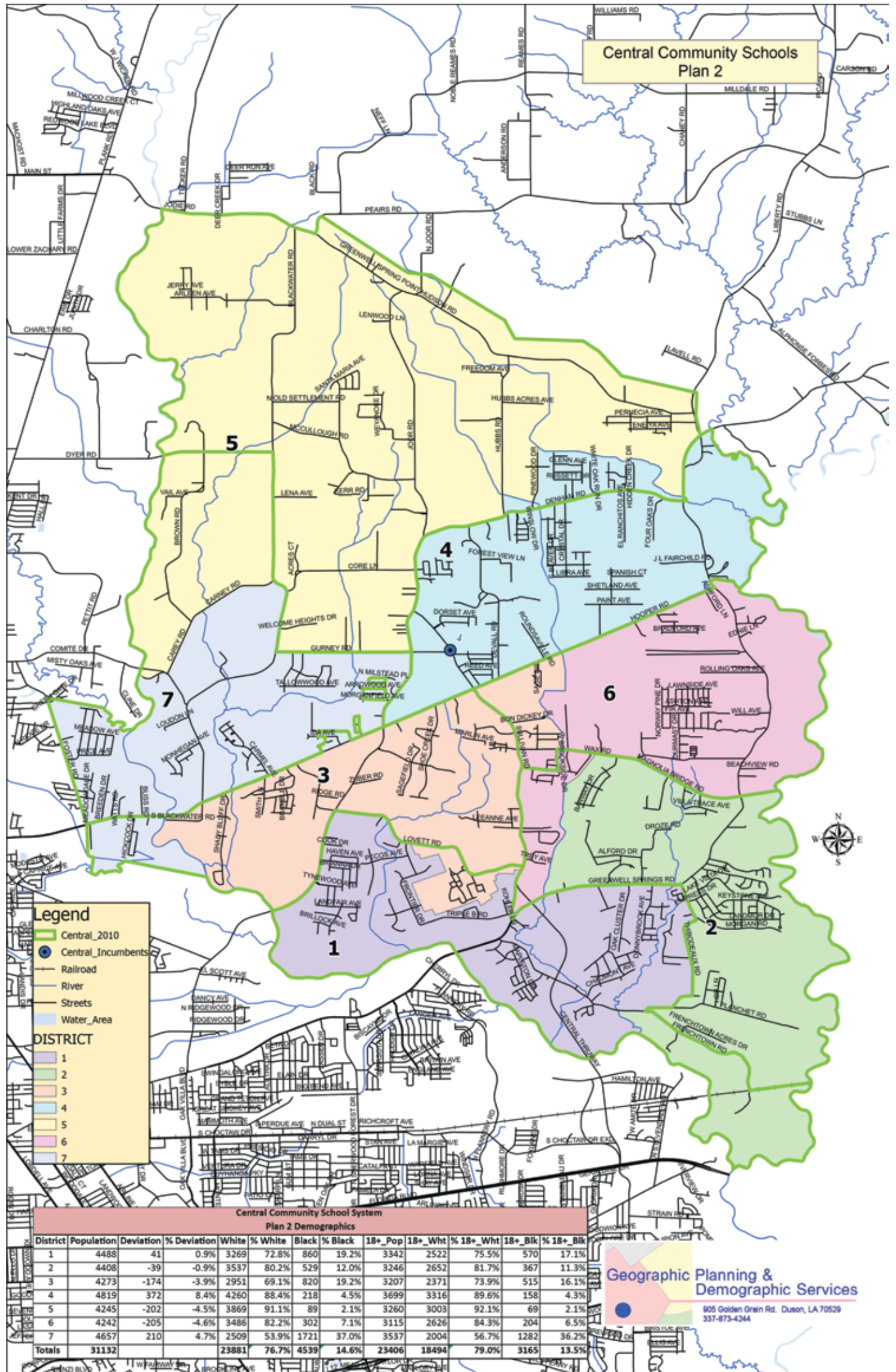
The reapportionment meeting has not yet been scheduled.

Reapportionment Of City Council Moving Forward, Mayor Reports

CENTRAL — Reapportionment of the Central City Council is moving forward. Mayor David Barrow told the *Central City News* that he and City Attorney Sheri Morris reached out to the same demographer working on Central School Board redistricting plans in December.

Mike Hefner, Chief Demographer of Geographic Planning & Demographic Services, LLC, in turn presented them with a cost proposal and scope of work along with some preliminary information based upon new Census numbers. The city’s redistricting plan will be used for the 2022 elections. Mayor Barrow said the firm’s fee will be \$12,900. He expects this matter will be before the Central City Council on Jan. 25.

The mayor said that based on



the numbers he’s seen, the district of City Councilman Josh Roy will need to give up some population, while the district of City Councilman Dave Freneaux will need to add some population.

With Central’s population near 30,000, each of the five Council districts will need close to 5,800 residents, Mayor Barrow said.

The primary election is Nov. 8 with runoffs on Dec. 10.
